

DIRECTIONS TO SHUFFLEBOARD COURTS

DELAND

West on SR 44. Cross over I-4. Travel past Kepler Rd. Take a half left turn on Voorhis Ave. At traffic light, turn left on Amelia Ave. and proceed .5 miles to courts on right.

DELTONA

Go West on SR 44 to Hwy 415. Left on Hwy 415 for 12.5 miles and turn right onto Ft. Smith Blvd. Travel several miles to Normandy Blvd. and turn left. Go to Hartley Ln and turn left. Then Left on Whitewood Dr. to Elgrove. Left on Elgrove (Small Sign to Vann Park) straight ahead to courts.

Alternate Route to Deltona Go West on SR 44 to I-4. West on I-4 to 111B Deltona (Saxon Blvd). At the 2nd traffic light turn right onto Normandy Blvd. Go about 1/4 mile and turn right onto Deltona Blvd for about 100 yards then take a quick left onto Whitewood Dr. After about a mile turn left onto Elgrove and the courts are straight ahead.

ORANGE CITY

West on SR 44 to I-4. West on I-4 to Exit 114. Head toward Orange City to first traffic light (rt 4101) and turn left. Proceed to next traffic light (Graves Ave) and turn right. Go several miles and just prior to US 17/92 turn right on Holly Ave. Courts are 100 yds on the right opposite the Fire Station.

ORMOND BEACH

Take I-95 North to Exit 273. Follow the clover leaf to the traffic light and turn left heading South on US-1. Go 1.7 miles to Hull Road. See sign for ORMOND BEACH SPORTS COMPLEX. Turn right and drive one mile and take the left fork in the road to the courts.

TAVARES Take Rt 44 to Eustis (about 1 hour) and turn left on Rt 19 to US 441. Turn right toward Tavares and turn left on St Clare (opposite Hardees). Turn right at sign to Public Library and the courts are straight ahead next to the Library.

MID FLA LAKES Take Rt-44 West through DeLand to Cassia and take half right (at big white house) on to 44A. Cross Rt 19 continuing on 44A to Mid Fla Lakes on left opposite concrete manufacturing plant.

LEESBURG Follow directions to Mid Fla Lakes and continue past Mid Fla Lakes to intersection with US 441. Turn right and move into left lane and turn left on Rt 44. Drive just past Hospital and turn right on Palmetto St and straight to courts.

HAWTHORNE Follow directions to Leesburg and continue past Palmetto St. to US 27. Turn left on to US 27 and continue on US 27 for 4 or 5 miles and turn left into Hawthorne.
